Enclosed please find a draft of the proposed 2017 Plan Rate Adjustments filing on behalf of Green Mountain Power (“GMP”), along with supporting documentation that is consistent with the documentation underlying prior base rate adjustments. This draft will now be reviewed by the Department of Public Service (“DPS”) and its independent consultant, Larkin & Associates. GMP will file a final version on August 1, 2016 for rates effective on a service rendered basis on or after October 1, 2016.


This is a draft of the second Plan Rate Adjustments filing that GMP will make under its revised Alternative Regulation Plan (“Plan”), approved by the Public Service Board (“Board”) in Docket 8910/8191. Under the Plan, GMP is to include the following adjustments with rates effective October 1, 2016: (1) each base rate adjustment; (2) the Q3 and Q4 2015 Power Adjustors and Q1 and Q2 2016 Power Adjustors; (3) the second year of the 2015 Major Storm Adjustment; and (4) the 2015 Earnings Sharing Adjustment Mechanism.
